The FDA, the explicit governmental agency specifically mandated with the task of protecting the public, in much of the public's view has become nothing more than the corporate shills for Pharma and much of the commercialized medical industry. The political machine (the politicians) have become little more than the corporate whores. We are witnessing the current system collapsing onto itself ... sort of a self-induced implosion ..., but one fueled by their own greed and deceit. The many good folks that are waking up to alternatives that have been there, but have not been able to be clearly seen as a result of massive and intentional misdirection, deception, withheld information, and outright lies will be the first to realize, utilize, and appreciate benefits of what the "lost art" of real healing has to offer.

WHERE WE ARE

Major authorities of the conventional medical industry (i.e. FDA, CDC, AMA, FAO, etc.) have been hiding behind the facade of protecting public health. These institutions, by the manipulation of Pharma, have really been working together to help generate the greatest profit while submitting the public to the effects of the well-marketed system of prescription drugs and commercialized medical routines which **normally** carry potentially negative effects. Over recent years, there has been much made public about very concerning issues within these entities, most especially the FDA. Scientists, doctors, and even high-level management have all been groups to come forward and admit that the misinformed public has been manipulated by the pharmaceutical and medical industries into believing that *health care* and taking prescription medications or using invasive routines are one in the same. This couldn't be more incorrect. Genuine health care includes actual *care* for the individual body and also taking healthy steps toward *preventing* illness or injury. This means treating the body well through nutritional dieting and healthy amounts of activity. It is also important to make sure to receive plenty of vitamins and micronutrients; none of which are supplied through the use of chemical prescriptions.

As there have been many excellent modern advancements in technology, the time it takes to accomplish many regular tasks has been greatly reduced. With the increase in pace of daily life, the demand for the fastest results to any process

has become its strongest. This demand for immediate responsiveness to any need has, unfortunately, also found its way into the field of conventional health care. It has been taken advantage of to perpetuate the idea of someday having a “quick fix” pill or antidote that would eradicate health problems in an instant. However, this ultimately endless pursuit only leads physicians to further dismiss and ignore the capabilities of holistic methods, which have been utilized for thousands of years. It also distracts many from considering that the actual repair necessary to accomplish a full recovery of health will always take time, and always much more time than is needed for significant damage to be done. With the many pollutants and toxins that humans are exposed to regularly, it doesn’t take much to cause damage at any degree. Sudden responses to the chronic exposure to (and also, very likely, the consumption of) these toxins or pathogens send panicked citizens to their physicians worried over their symptoms yet hopeful to be given a solution. However, the “solution” normally ordered is not curative at all, but is, in fact, just that: a *chemical* solution – inorganic and capable of causing adverse reactions (severe reactions in some cases). If the body does not accept it, it cannot heal the body. Many patients of the conventional medical system are realizing this now. While the FDA and its fellow medical agencies push legislation through Congress as the pharmaceutical industry continues to generate addiction and new “side effects”, groups of thousands mistreated by this system are piling their frustrations together and speaking out in order to bring change to American health care and hopefully topple the house of cards built around these harmful industries.

CONTINUING ISSUES WITHIN THE MEDICAL INDUSTRY

As was discussed in Pulsed Technologies’ previous article, “Fall of the House of Pharma: A Modern Day House of Cards, Part I”, there has been some very interesting activity within the giant conventional medical community recently. In 2008, a group of nine FDA scientists wrote to Michigan Rep. John Dingell and to President Barack Obama in 2009, accusing FDA managers of corruption. The scientists mentioned that they and others had been intimidated, coerced, and even threatened to manipulate research. Managers were also politically motivated to pressure scientists for the approval of medical devices they had originally determined as unsafe.



With the informed public becoming even more concerned over the vaccine controversy, we saw recently, Dr. Julie Gerberding’s sale of 38,368 of her personal Merck stock shares for \$2.3 million⁸. Dr. Gerberding, once in charge of the Centers for Disease Control and Prevention (CDC), is now the president of Merck’s Vaccine division. Merck is one of the largest pharmaceutical companies in the world, and the supplier of the largest number of vaccines the CDC recommends. Last year, Dr. Bernard Dalbergue, a former pharmaceutical industry physician with Merck, revealed to the French magazine *Principes de Sante* (Health Principles) that he believes the company’s Gardasil vaccine – which has been linked to controversy over its efficacy and potential

harmful side effects – will become the greatest medical scandal of all time. “Gardasil is useless and costs a fortune!” Dalbergue claims. “Decision-makers at all levels are aware of it!”⁹ From this perspective it almost seems that Dr. Gerberding may be abandoning a sinking ship, so to speak. The growing list of serious and concerning issues, along with many revealing accounts which should be embarrassing along with others that can be found (such as the fact that the


American government **does receive royalties** from the sale of Gardasil vaccines^{10 11}), have increased the awareness of many citizens when it comes to their dealings with conventional health care, and how they would begin to define it.

However, legal issues such as corruption, subversion, cronyism, potential racketeering, and a wink at what may seem as insider trading aren't the only issues within the market of conventional medicine. Actually, the conventional medicines themselves, which are constantly promoted as new innovations toward recovery, are the industry's biggest problem. All pharmaceuticals contain chemicals typically derived in part from petroleum-based feedstocks; some of these chemical blends help to suspend any natural ingredients (of which there is typically an ineffective amount) that may be used. Those inorganic chemicals and others within the medicines (such as mercury preservatives, etc.) are often carcinogenic and can have a great negative impact on individual health. Some have referred to these inorganic pharmaceuticals as "parasitic", robbing and stealing cells of their vital electrons – more knowledge is spreading about the effect of these electrons and how certain wholesome foods, natural supplements such as Vitamin C, and certain energetic procedures are helping many regain their depleted electrons and assist optimal metabolism to bring back desired health.

PHARMA INADVERTANTLY PROVIDING THE KEY

It may be somewhat ironic that the chemical "theft" of electrons described above may actually be the universal key to helping correct many dysfunctions NATURALLY and via very simple means using concepts readily available, just as effective, and at very low cost.

Doctor Linus Pauling was a two-time Nobel Prize winner and one of the founders of the fields of quantum chemistry and molecular biology. His work also included the extensive investigation into orthomolecular medicine, megavitamin therapy, and dietary supplements. However, Dr. Pauling's work with vitamin C was especially important in that it revealed the electrical (electron) nature and importance of these studied substances. It should be noted these latter listed efforts have NOT gained acceptance in the mainstream medical/scientific community¹² although more and more evidence is emerging that he was right all along.¹³



Dr. Thomas E. Levy aptly elaborated: "Another way of viewing this is that brisk electron flow and interchange equals health, impaired or poor electron flow and interchange equals disease, and cessation of flow and interchange equals death. Vitamin C, as the premier antioxidant in the body, is perhaps the most important ongoing electron donor to keep this electron flow at optimal levels." Levy says that, "Vitamin C, which is water soluble, helps to recharge oxidized vitamin E in those cell membranes back to the electron-rich reduced form. Even though vitamin C is not the primary antioxidant in the cell wall, it plays a vital role in maintaining the optimal levels of the metabolically active antioxidant, vitamin E, at that site."¹⁴

Hippocrates' statement over 2000 years ago, "Let food be thy medicine and medicine be thy food" is as valid now as it was then. The fact is, the organic foods available then were abundant with not only the nutritional components, but the bioavailable energy (aka. electrons).

Disease is never a result of a pharmaceutical deficiency!






